RECOMMENDATION

Auditor-Controller requests acceptance of various donations by individuals or organizations given to Napa County for the response to the 2019 Coronavirus, 2020 Napa Lightning Complex and 2020 Glass Fire.

EXECUTIVE SUMMARY

On August 19, 2020 the Napa County Public Health Officer declared a local health emergency referred to as the 2020 Napa Lightning Complex. On September 28, 2020, the Napa County Public Health Officer declared a local health emergency referred to as the 2020 Glass Fire. The Board of Supervisors authorized the Auditor-Controller to accept donations for the purpose of assisting with the cost of both events as well as the ongoing 2019 Coronavirus (COVID-19) Incident. Donations included both cash and in-kind to support the County's response to each event and report back to the Board quarterly. The County was overwhelmed with generosity from local business and county patrons that provided Personal Protection Equipment (PPE), Sanitizer, COVID-19 testing kits, as well as contributing money and meals during the events.
