SUBJECT: Revenue Agreement with the U.S. Department of Housing and Urban Development (Homeless

Management Information System)

RECOMMENDATION

Interim Director of Health and Human Services requests approval of and authorization for the Chair to sign a revenue agreement with the United States Department of Housing and Urban Development for a maximum of \$35,887 for the term April 1, 2017 through March 31, 2018 for the Homeless Management Information System Expansion program.

EXECUTIVE SUMMARY

The Homeless Management Information System (HMIS) Expansion revenue agreement will provide \$35,887 in grant funds that will help to fund the County's current agreement with Bitfocus, Inc., which is the County's HMIS software vendor. This grant will reimburse costs already incurred during the period April 1, 2017 through March 31, 2018.

Staff received the proposed grant agreement from Housing and Urban Development in May 2018.

Discretionary Justification: Approval of the requested action is discretionary in that there is no

mandate to accept the U.S. Department of Housing and Urban Development Grant funding for Homeless Management Information System (HMIS) activities. Approval of the requested action will, however, provide the County with necessary federal funding to assist with the yearly

cost to contract with HHSA's HMIS provider Bitfocus (\$73,165).

Is the general fund affected?

Future fiscal impact: None. The Federal Grant for HMIS activities covers the period of April 1, 2017

through March 31, 2018.

Consequences if not approved: If this agenda item is not approved, the County will be forgoing money to utilize

against the expenses of HHSA's HMIS system. The shortfall in funding will require the County to fund the entire Bitfocus contract with County General

Funds or end HMIS associated activities.

ENVIRONMENTAL IMPACT

BACKGROUND AND DISCUSSION

Napa County Health and Human Services Agency (HHSA) takes the lead on implementing the Homeless Management Information System (HMIS) for the Napa County Continuum of Care (CoC), a group of community stakeholders that work together to plan for and provide emergency, transitional, and permanent housing, as well as various services to address the needs of homeless persons. HMIS is designed to collect data on the homeless population of Napa County. The data collected helps staff better understand the needs of homeless individuals and families and assist in the development of more efficient delivery of program services for this population.HHSA's HMIS software vendor is Bitfocus, Inc.

Accepting this grant will help to fund software support costs already incurred.
