- 7. CONSIDERATION OF STATE LEGISLATION/ISSUES
 - **A.** County Executive Officer requests discussion and possible action on AB 50 (Kalra), a bill that incrementally increases the cap of available Assisted Living Medi-Cal Waivers from 5,744 to 18,500 and allows greater statewide availability to the program, to meet the needs of eligible older adults and people with disabilities.
 - **B.** County Executive Officer requests discussion and possible direction on SB 15 (Portantino), a bill that would require the county auditor of a county in which a redevelopment successor agency exists, to decrease the amount of county Education Revenue Augmentation Fund (ERAF) and to allocate a commensurate amount to the successor agencies to be used for specified purposes.
 - **C.** County Executive Officer requests discussion and possible direction on SB 5 (Beall), a bill that would allow local governments to collaborate on state-approved redevelopment plans, which would be funded by reduced contributions to Education Revenue Augmentation Funds.

- **D.** County Executive Officer requests discussion and possible direction on SB 152 (Beall), a bill that would shift the Active Transportation Program from the California Transportation Commission to the metropolitan planning organizations.
- **E.** County Executive Officer requests discussion and possible direction on SB 144 (Mitchell), a bill that would eliminate certain criminal justice administration fees.
