7. CONSIDERATION OF STATE LEGISLATION/ISSUES

- **A.** County Executive Officer requests discussion and possible action on SB 1120 (Atkins) a bill that requires ministerial approval of housing developments with two units (duplexes) and subdivision maps that meet certain conditions, and increases the length of time that cities and counties can extend the validity of existing subdivision maps.
- **B.** County Executive Officer requests discussion and possible action on AB 240 (Irwin) a bill that limits the term of a lease of real property at a California Department of Veterans Affairs (CalVet) Veterans' Home to five years, except under specified conditions; and requires that any use of property by a third party at a Veterans' Home meet specified criteria.
- **C.** Assessor Recorder County Clerk and Registrar of Voters requests discussion and possible action on SB 970 (Umberg) a bill that moves California's statewide primary election in gubernatorial years from March to June.
