## **RECOMMENDATION**

#### CALIFORNIA INTEGRATED WASTE MANAGEMENT ACT

DISCUSSION AND POSSIBLE ACTION: Staff to provide an update on the status of activities relevant to the Act.

#### **EXECUTIVE SUMMARY**

Waste Reduction and Recycling Activities Update:

<u>HHW Collection Event in Calistoga</u> - UVWMA staff has finalized agreements and advertised the HHW event scheduled for Saturday, Oct. 20 from 9 am to 3 pm at Calistoga. They have reserved the entrance by the north end of Fair Way for deliveries of HHW by the public. UVWMA will have its HHW contractor, PSC Environmental Services, ship and dispose of wastes accepted at the event. Staff will request Board input on planning for next year's event (location).

Paint Recycling - In 2010, the state legislature passed AB 1343, which transferred responsibility for paint recycling and disposal from government agencies to the paint industry. In response, the industry hired a non-profit, "PaintCare," to establish a statewide collection program. In phase I of the program, PaintCare started to negotiate contracts with local agencies for collection of paint from existing HHW collection sites. It intends to extend collections to paint retail stores in later phases. PaintCare has agreed, in initial discussions with UVWMA staff, to cover the costs of paint shipment and disposal from the existing recyclable HHW collection sites at Clover Flat Landfill and Yountville Corporation Yard and from temporary HHW collection events the agency may hold. The PaintCare program should reduce UVWMA's overall annual HHW collection costs by about 30%. Clover Flat Landfill should see an even greater percentage savings. CalRecycle must approve PaintCare's collection and financing plans before PaintCare can begin to implement the program. State approvals will not be completed before the October HHW collection event, but are expected to be finalized by Jan., 2013.

<u>Home Composting Workshops</u> – Workshop co-sponsors, UVWMA, Napa County, City of Napa, and Napa County Master Gardeners successfully hosted 9 workshops this year, including one on September 8 at Napa Valley

Museum, and on another on September 29 at Yountville Community Center. Staff will present the full summary of results at a future meeting.

<u>Beverage Container Recycling Program</u> - UVWMA has received and budgeted \$25,000 of state payment funds for beverage container and litter reduction activities. Staff plans to use the bulk of these funds for recycling collection at parks and schools, and for advertising.

Up-valley Regular Drop-off Recycling and Waste Collections

- Agricultural Chemical Container Recycling Event Napa County Agricultural Commissioner's Office has
  announced its plan to host another ag. chemical container collection event on Monday, November 5 at the
  Napa County Corporation Yard at 7292 Silverado Tr. in Yountville. The agency will announce the event to the
  public in the near future.
- Computers and Electronics Clover Flat Landfill accepted daily, during regular business hours
- <u>Fluorescent Lamps</u> from households only Central Valley Builders Supply and Steve's Hardware in St. Helena; Calistoga Fire Station, Silverado Ace Hardware, Vallarta Market, and Clover Flat Landfill in Calistoga; Pope Valley Market; College Hardware in Angwin; La Luna Market in Rutherford; and Yountville Corp. Yard - open during regular business hours
- Household Batteries from households only Napa Valley Coffee Roasting Company, Central Valley Builders Supply, and Steve's Hardware in St. Helena; Silverado Ace Hardware and Clover Flat Landfill in Calistoga; Town Hall in Yountville - during regular business hours
- Household Hazardous Waste Collection event is tentatively scheduled for October, 20, 2012
- Medications Disposal Up-valley residents can drop-off old or unwanted medications and used needles and lancets at Clinic Ole Offices – 661 Main St. in St. Helena; 911 Washington St. in Calistoga, during regular business hours
